New Major Infrastructure (MI) MPO Adopted Definitions

MI roadway projects:

- Capital projects on Interstate Highways; Principal Arterial Freeways and Expressways; or all sections of roadways classified as Principal Arterial "Other" that have fully or partially controlled access
- Projects that cost \$50 million or more

MI transit projects:

- Capital projects that add new connections to or extend the rail or fixed guideway transit network
- Projects that cost \$50 million or more

Fixed Guideway Definition – FAST Act Definition

- Fixed guideway is defined as projects "using and occupying a separate right-of-way for the exclusive use of public transportation; using rail; using a fixed catenary system; for a passenger ferry system; or for a bus rapid transit system."
- Fixed guideway can include heavy rail, light rail, commuter rail, streetcars, trolleybus, bus rapid transit, and ferries.
- This definition eliminates bus service operating on highoccupancy vehicle lanes or high-occupancy toll lanes from qualifying as fixed-guideway service.
- It does not allow for corridor-based bus rapid transit projects without a separated right-of-way dedicated for public transportation along the majority of the route.

Policies on MI Project Scoring – Current MI Project Scoring and Practices

- Currently, MI projects in the Long-Range Transportation Plan (LRTP) are scored with LRTP criteria on how well the project addresses the MPO's goals and objectives using available data, some of which may be very preliminary.
- In most cases, projects are assumed to automatically be programmed in the Transportation Improvement Program (TIP) once they are listed in the LRTP.
- A project may be rescored as part of the TIP process, but not necessarily compared to other projects under consideration.

Policies on MI Project Scoring – Staff Recommendation

- All projects being considered for the LRTP continue to be evaluated on how well they address the MPO goals established in the LRTP, and are assigned an LRTP score regardless of the design status.
- Any MI projects that have advanced to the 25 percent design phase will also get a TIP score using the TIP criteria.
- The MPO should consider a formal policy of rescoring all MI projects when the projects are ready for programming in the TIP, with the assumption that the project will not automatically be programmed in the TIP.

- The MPO should consider a policy that the status of all MI projects included in the previous LRTP be reviewed during the development of a new LRTP to ensure that projects are moving forward.
- If there is no movement in design or approval or if a schedule for implementation is not available, the MPO should consider placing the project in the Universe of Projects for consideration in future LRTPs.

Recommendations on Scoring and Programming

Scoring

- Develop a two-step scoring process
 - Each project receives an LRTP score using the same criteria
 - Any project at 25 percent design receives a TIP score

Programming

- Review the status of MI projects in the previous LRTP
- If no movement in design or approval, or if a schedule for implementation is not available, consider placing project in the Universe of Projects for future consideration

Feedback

- 12 questions about the main proposed criteria changes
 - 60% to 79% fully support the change
 - 16% to 29% somewhat support the change
 - 1.7% skip rate
- Respondents provided 48 to 160 comments per criteria question
- When asked about weighing MPO goal areas out of 100 points, respondents gave goal areas between 15 and 21 points each
- Respondents shared that healthcare facilities, utilities, schools, permanent and emergency shelters, grocery stores, and emergency response facilities were the most important, and gas stations were the least important
 - Many suggested churches and pharmacies as additional critical facilities
