Dear Mr. Mohler,

As Chair of the Belmont School Committee, I write regarding the Belmont project under your consideration, the "Community Path." The School Committee and Superintendent have reviewed and endorsed this letter. We support the Belmont Community Path project.

The School Committee and School Department have worked cooperatively in the preceding years to account for this major infrastructure project, while moving forward with a major school renovation.

The School Committee recognizes the needs of all families with respect to transportation modes and resources, and strives to ensure safe and accessible arrival to and dismissal from all schools while complying with related state and federal regulations. The School Committee recognizes that the schools are major transit activity generators; reducing vehicular activity in the school zone improves safety.

The School Committee, School Department, and the Belmont High School Building Committee recognized and integrated planning for the anticipated Alexander Underpass, for its safety and access improvements to the newly designed campus. The Building Committee incorporated general pedestrian and bike improvements by reducing student parking on campus and creating additional sidewalk/shared path access routes. The campus will nearly double its student population, serving about 2,200 students.

High school students in the Global Capstone course studied commute patterns/modes to the campus in 2017 in preparation for the building project. They found that 16% of students walk or bike, and proposed ideas for increasing such transit with incentive programs (walk/bike with contracts) and increased bike racks. Their surveys revealed families' desire for better bike lanes and support for bike culture, as well.

In relation to walking and biking transportation, the Belmont Schools have taken steps to support students and families in other ways, including:

- Provided review and input to the Complete Streets prioritization plan (school routes);
- Coordinates with Belmont Police Department for School Crossing Guards;
- Collaborated with Community Development Dept. to improve safety zones with signage and infrastructure improvements in school zones;

- Supports Safe Routes to Schools (MA DOT) program at the elementary and middle school level in partnership with parent-teacher organizations;
- Supported 4 different school-based applications to MADOT/Safe Routes to Schools Infrastructure Assessment Award program; and
- Supporting the MA DOT/SRTS award/project for the Wellington School.

The School Committee approved as part of the ongoing operational work of the district, to: "continue to collaborate...and to work toward the goals of Belmont's Climate Action Plan." The 2007 plan states that 37% of Belmont's carbon emissions by source are attributed to transportation. The 2018 update identified the majority of emissions by source attributable to transportation and heating. It sets a target of 50% electric vehicles by 2030, while acknowledging non-emitting sources must be sustained to achieve target reduction levels.

School bus transportation costs continue to outpace revenue growth and the district relies on fees paid by families to offset these escalating bus costs. With Belmont being small, a significant percentage of students live well within 2 miles of the school they attend; by law, the district is not obliged to provide transportation for a majority of students. The Committee recognizes that welcoming and safer pathways for students to bike and walk supports students who utilize this affordable transportation option, while reducing bus demand. Neighboring peer districts Lexington, Arlington, Newton, and Melrose have integrated multi-use paths into arrival/dismissal plans and school maps successfully.

The Committee recognizes that active transportation has a positive impact on student health. The model Wellness policy for schools provided by the USDA and CDC states that "...physical activity before, during and after the school day, are strongly correlated with positive student outcomes." And that, "...students who are physically active through active transport to and from school, recess, physical activity breaks, high-quality physical education and extracurricular activities – do better academically." The model policy includes "active transport to and from school, such as walking or biking" as an area of wellness to promote. Belmont currently does several of the suggested activities outlined in the model. The Path would provide free and accessible recreation space. Peer districts have utilized paths for Wellness and physical education programs, as well as team-athletic training.

Finally, although the School Committee has not thus far deemed it necessary to take a position on any particular segments of the planned route, it has consistently identified the Alexander Underpass as a critical safety improvement for students and families.

In accordance with the annual FFYs 2022-2026 Transportation Improvement Program (TIP) comment period, the undersigned residents of Weston would like to offer public comment regarding project #608954, the Route 30 Reconstruction project in Weston.

This proposed \$8,117,562 project (initial estimate) would have long-lasting implications for all who use the Route 30 corridor from Natick to Newton. The project envisions a reconstruction of the roadway, intersection improvements, two new traffic signals and a bi-directional shared use path primarily for bicycle transportation on the south side of Route 30 (South Avenue) for most of the 3.4-mile corridor. At present, 25% design plans have been submitted by the Town and their designer, Howard Stein Hudson, to the District 6 office and MassDOT for preliminary review.

While there are components of the overall plan that are favorable and will result in improved conditions and safety in the corridor, we are extremely concerned about the extensive 3.4-mile shared use path that has been proposed, that in our view will result in a degradation of public safety for bicyclists, pedestrians, and motorists alike. In short, there are numerous viable alternatives to the proposed bi-directional shared use path that were given little or no consideration in the Town's pre-25% planning process, and this remains a major concern of residents.

We strongly support bicycle facilities, provided they are designed consistent with state and federal standards for roadways such as South Avenue (Route 30), and we urge a rethinking of the plans that have now been submitted to MassDOT.

In this comment letter we are forwarding to the MPO our most critical areas of concern about the shared use path aspect of the project. Our concerns have been reinforced in discussion with numerous residents, and this number will only expand as many other residents learn what is proposed and voice their concerns about the project. It is our ultimate goal in drafting this letter to urge the Town, in conjunction with MassDOT, to develop ways to seek broad input, seriously consider other design alternatives, and to craft project plans that will have substantial, if not unanimous, community support.

Proposed Shared Use Path

The current proposed plans call for a 2-way shared use path (primarily a bicycle access facility, sometimes called a sidepath) of 10 feet in pavement width from the Natick town line to Park Road (Turnpike access road) close to the Newton city line. The southerly side of South Avenue (even numbered addresses) in this corridor would be designated for this purpose.

The project segment length is 3.4 miles on the southerly side of South Avenue from the Natick town line to Park Road. The Route 30 corridor handles an average daily traffic volume of approximately 17,000 to 18,000 vehicles per day (as of September 2018), depending on the location.

Approximately 1.8 miles of the South Avenue corridor are characterized by numerous driveways and street intersections, resulting in **47 crossings** that intersect with South Avenue on the southerly side, outlined as follows:

• Single-family residences (26) creating a total of **30 driveways** that connect to South Avenue.

- Non-single family uses (or multi-purpose properties) (8) creating a total of **9 driveways** that connect to South Avenue.
- **8 intersecting streets** that connect with the southerly side of South Avenue.

In the 1.8 miles where these **47** crossing points occur, there is an average of **one crossing point every 202 feet**. This creates a high-stress environment for potential users of the proposed shared use path.

Within the 1.8 miles there are **78 households** that access South Avenue exclusively from the crossing points on south side as the only means of egress from their address. Motorists leaving and returning to these 78 households must cross the proposed shared use path – there are no alternative routes. The high number of motorist crossings make it imperative to consider operational and safety issues in the design of any bicycle facilities on the roadway.

Operational Issues with Bi-directional Shared Use Paths

The AASHTO "Guide to the Development of Bicycle Facilities", 2012, 4th edition, is an industry-standard publication for the design of bicycle facilities. Chapter 5, "Design of Shared Use Paths", devotes 56 pages to the subject of operational concerns. Section 5.2.2 addresses the use of shared use paths designed for two-way bicycle traffic on a separate right of way, as is proposed for South Avenue.

As noted above, there are 47 crossing points at driveways, roadway intersections, and businesses along the south side of the South Avenue corridor, creating high-stress areas of the proposed path. Note that, per AASHTO, page 5-8 (emphasis added):

"Before committing to this option (two-way bicycle traffic on a shared use path) for longer distances on urban and suburban streets with many driveways and street crossings, practitioners should be aware that two-way sidepaths can create operational concerns.

These conflicts include: (14 conflicts are listed in the guide, 4 of which are emphasized below)

- 1. At intersections and driveways, motorists entering or crossing the roadway often will not notice bicyclists approaching from their right, as they do not expect wheeled traffic from this direction. Motorists turning from the roadway onto the cross street may likewise fail to notice bicyclists travelling the opposite direction from the norm.
- 2. Bicyclists travelling on sidepaths are apt to cross intersections and driveways at unexpected speeds (i.e., speeds that are significantly faster than pedestrian speeds). This may increase the likelihood of crashes, especially where sight distance is limited.
- 3. Motorists waiting to enter the roadway from driveway or side street may block the sidepath crossing, as drivers pull forward to get an unobstructed view of traffic (this is the case at many sidewalk crossings, as well).
- 4. Attempts to require bicyclists to yield or stop at each cross- street or driveway are inappropriate and are typically not effective.

For these reasons, other types of bikeways may be better suited to accommodate bicycle traffic along some roadways."

The "MassDOT Separated Bike Lane Planning & Design Guide", 2015, <u>https://www.mass.gov/lists/separated-bike-lane-planning-design-guide</u> lists several examples that corroborate the operational issues outlined in the AASHTO guide.

Draft FFYs 2022-26 Transportation Improvement Program

Chapter 2, page 15: Travel Direction (emphasis added)

"One-way separated bike lanes in the direction of motorized travel are typically the easiest option to integrate into the existing operation of a roadway. This configuration provides intuitive and direct connections with the surrounding transportation network, including simpler transitions to existing bike lanes and shared travel lanes.

Providing a two-way facility introduces contra-flow movements which can be challenging to accommodate. Contraflow movements require special attention at intersections, driveways, and other conflict points as people walking and driving may not anticipate contra-flow bicycle movements. It is particularly important to consider options for managing potential conflicts between contra-flow bicyclists and left turning motorists, in this scenario motorists are primarily focused on identifying gaps in oncoming traffic and may be less cognizant of bicyclists approaching the intersection."

Chapter 4, page 65: Left Turning Motorist

This section explains the operational drawback of a two-way bike lane on streets with characteristics such as those that exist on South Avenue:

"On streets with two-way traffic flow, the operational dynamic of a motorist looking for gaps in traffic creates unique challenges that cannot be resolved strictly through the provision of parking restrictions to improve sight distance. This is a challenging maneuver because the motorist is primarily looking for gaps in oncoming traffic and is less likely to scan for bicyclists approaching from behind. The motorist will be accelerating towards the crossing once they perceive a gap in traffic. This creates a higher potential for conflict on streets with:

- High traffic volumes and multiple lanes
- Higher operating speeds
- Heavy left turn volumes"

The "Masstrails August 2018 Shared Use Path Planning Primer" https://www.mass.gov/doc/shared-use-path-planningprimer-0/download provides additional guidance that further underscores safety as a top priority (emphasis added):

Page 2: Sidepath – "Sidepaths are shared use paths that run adjacent to roadways...They can provide direct access to businesses, schools, and other destinations, but safety at intersections and driveways must be carefully considered during planning and design."

Page 3: What is the Vision? – "... Every path should be Safe: a safe path is one designed to reduce the likelihood of conflicts between travel modes and reduce crash severity both along the path and at roadway crossings."

With respect to the Route 30 project, there has been a lack of consideration given to the numerous driveway crossings and intersections along significant portions of the proposed path. These crossings pose dangerous situations for motorists and all users of the path.

A bi-directional shared use path is not a safe option for South Avenue.

In addition to the operational concerns associated with bi-directional shared use paths listed above, we note the following operational and safety issues specific to South Avenue:

- The federal and state guidelines recommend that other types of bicycle facilities are likely better suited to ٠ roadways like South Avenue.
- The close proximity of the shared use path to the road and the bi-directional bicycle traffic on the path increase the possibility of conflicts (collisions or avoidance maneuvers) that could force bicyclists (or pedestrians and student athlete runners/joggers) off the path into oncoming traffic.
- The close proximity of driveways and streets a driveway or street intersection every 202 feet along the . majority of the proposed shared use path creates a high-stress environment for bicyclists that increases the probability of accidents, especially in the westbound (contra-flow) direction.

- Steep grade changes and significant traffic noise make it challenging for bicyclists to perceive immediate threats to their safety and to communicate hazards to others on the path.
- The safety concerns are amplified by the numerous visitors, service providers, delivery trucks, etc. to these residents and businesses who will not be familiar with the bi-directional bicycle travel on the shared use path.

There is no question that safety must be a top priority for the reconstruction project. To date, many safety issues with the proposed shared use path have been left unaddressed by the consultant, despite numerous comments and questions regarding the issue of the proposed bi-directional shared use path on South Avenue.

New Traffic Signals and Community Participation

In addition to the shared use path, two new traffic signals at the intersections of Route 30 with Winter Street and Oak Street have been proposed and require more in-depth study. Public input to the design process has been limited, many affected residents were not notified about the project, and safety and operational concerns voiced at meetings remain unaddressed.

- Howard Stein Hudson cited accident rates of .53 at each intersection where new traffic signals are proposed. This is only .01 above the average accident rate at similar intersections in the region – this small difference warrants discussion of less intrusive measures to improve safety.
- No study has been done to illustrate any adverse effects the new traffic signals would have on traffic queueing that is already excessive along Route 30 during peak commuting hours.
- Alternatives to signals that could help to improve safety at those intersections such as improved signage and clearer pavement markings were not considered in public meetings.
- The scope of the proposed Route 30 project was not sufficiently advertised to affected residents, and input from residents was limited.
- Questions regarding alternative designs and concerns about safety were dismissed during public meetings.

We strongly encourage consideration of alternative designs for these significant proposed changes to Route 30, especially where the proposed design contradicts industry-standard recommendations for safety.

In summary, we the undersigned residents of Weston have numerous concerns about the proposed Route 30 Reconstruction plans that have been submitted by the Town to MassDOT for 25% design review. The proposed bidirectional shared use path raises numerous public safety issues, the two proposed traffic signals need further analysis, and a much fuller and engaging public participation process with affected residents needs to occur before widespread community support for the Route 30 Reconstruction project can be realized. In particular, viable and safe alternatives for bicycle facilities must be a top priority. We ask the Boston MPO to be aware of these concerns in the FFY 2022-2026 TIP program as well as in future years as this project is considered for further design and potential funding.

I am writing to offer the Town of Burlington's full support for advancing the intersection reconstruction at Route 3 (Cambridge Street, Bedford Street and South Bedford Street) in Woburn and Burlington. This project is currently scheduled for TIP funding for Federal Fiscal Year (FFY) 2025; however, the we note that the project will be ready far before that timeline.

The Town of Burlington is working closely with the City of Woburn to prepare this intersection for these critically needed improvements. This area of Burlington has been growing over the past 10 years at the Oracle campus, the Trustee's property at <u>Mary Cummings Park</u>, <u>Northeastern's Innovation Campus at Burlington</u> and recent growth in the life science industry with <u>Azzure Cleanrooms on Demand</u>. The intersection at Cambridge Bedford/South Bedford Street is a critical problem for traffic circulation and safety in the area.

The Town has been able to work with area property owners to secure needed funding to develop the plans necessary to submit the project to the Transportation Improvement Plan and to identify and preserve over 9 acres of land through a conservation restriction. The importance of the latter measure is to satisfy any Article 97 of the Massachusetts Constitution requirements for land replacement obligations due to required takings to effectuate the above referenced improvements in the intersection. The Burlington Selectboard endorsed the restriction at their meeting of May 24, 2021.

The Town of Burlington is working alongside the City of Woburn on this effort and the Town would like to strongly advocate for this project to be considered for funding ahead of the 2025 timeline. The project is underway in the design phase and the Article 97 hurdles have been removed.

Hope all is well with you and beloved ones!

As a new Newton, MA resident, who grew up poor in a Brazilian *favela*, it is concerning to learn that Newton's commuter rail service has been dropped from the State's draft 2022-26 Transit Improvement Plan. It's also extremely concerning to find out that station accessibility improvements for Auburndale, Newtonville, and West Newton have also been removed from TIP.

It's my understanding that "the MBTA completed the design for all 3 stations in 2019." People with disabilities or limited mobility - including some elderly, some pregnant women, parents using strollers and people with obesity - need better accessibility everywhere, including Newton.

The commuter rail project is long overdue, according to GreenNewton. "It was almost 20 years ago that then-Congressman Barney Frank secured \$3 million in Federal funding for the Newton Commuter Rail Accessibility Project." I am aware that investing in affordable housing is a priority for Newton's local government. By dropping Newton stops from the commuter rail project, the state is directly causing a negative impact on Newton's equity (not everyone can afford driving to their workplace or to access leisure options) and environmental (reducing greenhouse emissions and particulate matter pollution) efforts.

How can Newton advance its housing and environmental goals at the needed fast pace when important infrastructure is denied to the city?

Matt,

I understand that the long-anticipated accessibility upgrades to the three Newton MBTA stations are in danger of being removed from the 2022-26 Transit Improvement Plan.

This would have disastrous consequences for all riders - those with handicaps and those without. The access to these stations – with extremely steep stairs – is currently unsafe for all riders, and is impossible for those with any physical disability. To further specify legal requirements for providing equal access for people with disabilities, the ADAAA law was passed in 2008. As Title II of that law specifies below, **"all public transit systems, including commuter and inner-city rail, must provide access for people with disabilities."** Thus, the MBTA is in violation of that law and is subject to legal action.

Particularly in Newtonville, there has been tremendous multi-family development to provide both market-rate and affordable housing. That increased population in that village center has and will continue to increase dramatically the number of people with disabilities who are local residents and dependent on public transportation. My adult son, Nathan Persampieri, is one of those residents. He requires the aid of a walker for his mobility. Nathan was part of the study to redesign the Newtonville station. He's been waiting and counting on that station being renovated to enable him to commute into downtown Boston for his job. To push that possibility out to beyond 2026 eliminates a critical piece of his access to employment in downtown Boston.

Quite simply, the accessibility improvements in all three Newton stations need to be reinstated into the Transit Improvement Plan. To exclude them continues the MBTA's violation of ADAAA.

The Americans with Disabilities Act (ADA) became law in 1990. The ADA is a civil rights law that prohibits discrimination against individuals with disabilities in all areas of public life, including jobs, schools, transportation, and all public and private places that are open to the general public. The purpose of the law is to make sure that people with disabilities have the same rights and opportunities as everyone else. The ADA gives civil rights protections to individuals with disabilities similar to those provided to individuals on the basis of race, color, sex, national origin, age, and religion. It guarantees equal opportunity for individuals with disabilities in public accommodations, employment, transportation, state and local government services, and telecommunications. The ADA is divided into five titles (or sections) that relate to different areas of public life.

In 2008, the Americans with Disabilities Act Amendments Act (ADAAA) was signed into law and became effective on January 1, 2009. The ADAAA made a number of significant changes to the definition of "disability." The changes in the definition of disability in the ADAAA apply to all titles of the ADA, including Title I (employment practices of private employers with 15 or more employees, state and local governments, employment agencies, labor unions, agents of the employer and joint management labor committees); Title II (programs and activities of state and local government entities); and Title III (private entities that are considered places of public accommodation).

Title II (State and Local Government)

Nondiscrimination on the Basis of Disability in State and Local Government Services

Title II of the ADA prohibits discrimination against qualified individuals with disabilities in all programs, activities, and services of public entities. It applies to all state and local governments, their departments and agencies, and any other instrumentalities or special purpose districts of state or local governments. It clarifies the requirements of section 504 of the Rehabilitation Act of 1973, as amended, for public transportation systems that receive federal financial assistance, and extends coverage to all public entities that provide public transportation, whether or not they receive federal financial assistance. It establishes detailed standards for the operation of public transit systems, including commuter and intercity rail (e.g., AMTRAK).

This title outlines the administrative processes to be followed, including requirements for selfevaluation and planning; requirements for making reasonable modifications to policies, practices, and procedures where necessary to avoid discrimination; architectural barriers to be identified; and the need for effective communication with people with hearing, vision and speech disabilities. This title is regulated and enforced by the U.S. Department of Justice.

Without a doubt, the most common question I hear from residents is: how can we make the BFRT a reality in Sudbury?

In the past year, Sudbury has made significant progress toward the completion of the design and is currently on track to advertise for construction in spring 2022. Just recently, Sudbury submitted the 75% Design plans to MassDOT. There is town-wide support for these plans. The Select Board voted 5-0 in support of these plans, the citizens' Bruce Freeman Rail Trail Design Advisory Task Force voted unanimously to support these plans, and Sudbury Town Meeting voted in September 2020 in favor of an Article directing town staff and boards to expedite the completion of the design of the BFRT. Sudbury is ready to do its part.

As a former member of the Conservation Commission and its designee to Sudbury's Bruce Freeman Rail Trail Design Task Force, which advised on alternative routes as part of the 25% design in 2017, I am familiar with both the design challenges and ultimate benefits to residents that the BFRT offers. A well-designed rail trail offers significant enhancements to the recreational, liveability, and sustainability opportunities in town. The connectivity that the BFRT provides extends these benefits across the region.

Not long ago, I rode the BFRT in Concord and spoke with a couple who had come from Andover to enjoy the trail in Concord. This shows how a local project can provide regional benefits, which the BFRT Phase 2D offers. Completing the 4.6-mile section in Sudbury would extend the BFRT to 20 miles in total, and connect the commercial district in West Concord with the commercial district in Sudbury. This connection will add to economic development and provide riders with greater access to amenities.

As a resident, I look forward to enjoying the long-overdue BFRT. As a Select Board member, I offer support and cooperation in making it a reality. Thank you for the opportunity to comment and your continued support for TIP funding for the the Bruce Freeman Rail Trail (BFRT) Project, Phase 2D (608164) for FY2022.

Dear Boston Region Metropolitan Planning Organization (Boston MPO),

We the undersigned, advocates, users, and <u>Friends of the Bruce Freeman Rail Trail (BFRT)</u> strongly support the inclusion of the <u>Sudbury and Concord: Bruce Freeman Rail Trail, Phase 2D</u> project (Project ID 608164, BFRT Phase 2D) for federal fiscal year (FFY) 2022 construction in the <u>Draft FFYs 2022-2026 Transportation Improvement Program (TIP) document</u>.

Phase 2D of the BFRT (Project ID 608164) will constitute almost 5 miles of trail including the unbuilt portion of the BFRT Phase 2C from Powder Mill Road in Concord to the Sudbury town line, and the 4.6-mile Sudbury segment from Concord Town line south to Station Road. Phase 2D of the BFRT will connect to approximately 14 miles of the BFRT to the north which is either built or under construction (Phase 2B the one-mile section dominated by the bridge over Route 2 in Concord and Acton is now scheduled to open in spring 2022).

We thank the Boston MPO for including BFRT Phase 2D for advertisement for construction for FFY 2022 in the FFYs 2022-2026 Draft TIP.

The BFRT and rail trails in general have many benefits.

- Safe transportation route to destinations, which there are many along the BFRT and include connections to the BFRT to the north and the east-west Mass Central Trail at Sudbury Station Road. When complete some connections to the BFRT include
  - West Concord MBTA station
  - Businesses (many small businesses, but also Crosspoint Tower in Lowell)
  - Schools (Sanborn School in Concord, and Byam School in Chelmsford)
  - Recreation areas (including Davis Field & Featherland Park in Sudbury, NARA Park in Acton)

  - Numerous conservation areas in Sudbury, Concord, Acton, Carlisle, and Chelmsford.

On behalf of the 495/MetroWest Partnership, please accept the following as our official comments to the Boston Region Metropolitan Planning Organization (Boston MPO) regarding the draft *Transportation Improvement Program* (TIP) for FFY 2022-26.

The 495/MetroWest Partnership is a unique public-private collaboration among businesses, municipalities, and other stakeholders focused on creating an environment that prepares for and cultivates sustainable growth across our 36-community region. The Partnership accomplishes this by providing coordination, education, and advocacy for solutions to regional constraints. The key priorities that the Partnership addresses within the 495/MetroWest region are separate and unique, but operate as part of an interrelated network of regional needs. These areas of focus include economic development, transportation, housing, energy and sustainable development, and water resources, among others.

Given the unprecedented and protracted nature of the economic challenges facing the Commonwealth and our region as a result of the COVID-19 pandemic, we recognize the diligence of the Boston MPO and your continued efforts in cultivating a resilient regional transportation network.

As statewide traffic volumes continue to increase week by week, and as large employers continue to roll out plans to return staff to on-site work, we anticipate the same transportation challenges that threatened the economic vitality of the region prior to the statewide lockdown will soon fully reemerge. Other indicators, such as increases in the cost and total sales of single-family homes and condominiums in the 495/MetroWest region, suggest our communities remain a desirable place to relocate to. Despite a sharp 8.5% rise in median single-family home prices across the overlapping 495/MetroWest and Boston MPO communities from 2019 to 2020, the number of total sales also increased, indicating strong buyer demand, presumably from families and individuals of prime working age that will need efficient, reliable, and multimodal transportation options.

The Partnership greatly appreciates the 495/MetroWest projects included in the FFY2022-26 TIP. The Partnership strongly supports the inclusion of the following projects in the current draft TIP (with newly added projects emboldened for reference):

We greatly appreciate the inclusion of funding for project #612099 in Ashland, which was not included in last year's TIP. This project would replace the existing bridge on Cordaville Road over the Sudbury River, which is proximately located next to the largest Commuter Rail parking lot on the Framingham/Worcester line, as well as several local parks. We also appreciate the inclusion of a digital parking management system for the South Acton Commuter Rail station's five lots, and that project #608255 in Stow was bumped up the TIP to FY23 from FY24. We are concerned, however, that project #608443 in Littleton, #608480 in Foxborough, #607748 in

Acton, #608045 in Milford, and #609402 in Framingham and Natick have slipped down the TIP to later funding years. We are disappointed that #609402 - Framingham and Natick: Resurfacing and Related Work on Route 9 has slipped further down the TIP for a second consecutive year, despite a programming decrease of \$7.63 million. As design concept refinements made to "The Throat" continue to delay the construction timeline for the Allston Multimodal Project, 495/MetroWest businesses and residents remain concerned that Route 9, already heavily encumbered with local traffic, will be ill-equipped to handle additional spillover traffic. The probability that resurfacing work on Route 9 in Framingham and Natick could align with the Allston Multimodal Project construction timeline exacerbates these concerns; project staging and timing for Route 9 work must be planned to minimize traffic disruption and aggressively communicated to the public.

We commend MassDOT and the Baker-Polito Administration for their leadership in funding the long-needed I-495/I-90 Interchange Improvement project, and advancing it through to the Final Environmental Impact Report. We appreciate the increase in total funds programmed across FY22-27, and continue to look forward to the positive impacts this project will have on not only the 495/MetroWest region, but on the many motorists from around the Commonwealth who utilize this interchange on a daily basis. A related project, the I-495/Route 9 interchange project, deserves future funding consideration given its proximity and interdependency with the I-495/I-90 interchange, and the area's key role in serving freight across Eastern Massachusetts.

Consistent with our record of addressing suburban mobility challenges, promoting regional connectivity, and accentuating our region's natural landscapes and recreational opportunities, the Partnership supports the two Bike & Pedestrian projects in our service area: #608164 - Sudbury and Concord: Bruce Freeman Rail Trail (Phase 2D) into Sudbury, and #610680 - Natick: Lake Cochituate Path. The Lake Cochituate Path would divert users away from a geometrically complex intersection at Route 9 and Speen Street and connect users to the Natick segment of the Cochituate Rail Trail, which is currently under development.

The Partnership would like to express our disappointment that #610660 - Sudbury and Wayland: Mass Central Rail Trail (MCRT), which was included in last year's TIP, was subsequently removed from the FFY 2022-26 draft TIP. The expansion of the Bruce Freeman Rail Trail into Sudbury would connect with the proposed segment of the Mass. Central Rail Trail from Wayland into Sudbury along Route 20. We are disappointed that an opportunity for interconnectivity between two regionally significant, yet heavily segmented corridors will not come to fruition in the next several years.

We appreciate ongoing reforms at MassDOT and the MBTA under the leadership of Governor Baker, Lt. Governor Polito, and acting Secretary Tesler. We recognize the MPO was limited in its financial capacity to fund new projects given the cost increases for many projects programmed in previous TIP cycles, but remain perplexed by the significant amount of unprogrammed regional target funds compared to previous TIP cycles. The Boston Region MPO Regional Target Investment Summary shows that un-programmed funds accounted for 0.2% (\$1,257,656) across MPO investment programs in FY21-25, while accounting for 3.8% (\$20,496,035) in FY22-26. These funds could have supported several regionally significant Complete Streets or Intersection Improvement projects. Additionally, we remain disappointed that for the third consecutive TIP cycle, MetroWest Regional Collaborative communities received the smallest proportion of regional target funds. The Partnership would also like to offer our support for a number of significant projects that have entered the TIP universe:

- 610702 Littleton: Intersection Improvements at Route 119/Beaver Brook Road
- 610553 Acton: Improvements at Route 2 Eastbound Ramps at Route 27
- 609280 Framingham: Roundabout Construction at Salem End Road, Badger Road and Gates Street
- 610691 Natick: Cochituate Rail Trail Extension, from MBTA Station to Mechanic Street
- 607774 Franklin: Resurfacing and Intersection Improvements on Route 140, from Beaver Street to I-495 Ramps
- 610676 Wrentham: Intersection Improvements on Route 1A at North and Winter Street
- 611932 Hopkinton: Campus Trail Connector, Shared Use Trail Construction
- 604862 Bellingham: Ramp Construction & Relocation, I-495 at Route 126 (Hartford Avenue)

# Page ES-5:

Transit Modernization should receive more allocated funding. Prioritizing transit modernization has manifold benefits through positive economic, environmental, and social impacts. Modernization can spur greater efficiency and frequency of all transit routes, especially those conducive to heavy rail along key commuter routes from Massachusetts's Gateway cities, such as Chelsea. Rapid modernization of public transit is imperative in addressing congestion and socioeconomic issues associated with pre-pandemic inequities which have now been amplified by Covid-19 public health concerns, such as overcrowding in public transit onboarding and off boarding facilities and within transit vehicles themselves. Modernization policies should center around increase of service along commuter rail lines, electrification of system with no intermediate diesel electric hybrid, fee transfers, and pushing forward on design/construction of the North-South Rail Link.

Additionally, more funding should be allocated to intersection improvements which prioritize pedestrian and bicyclist safety, while integrating smart signalization features that can help allay congestion, reduce air pollution, and complement the significant financing dedicated to the Community Connections program and Bicycle and Pedestrian improvements. Dense municipalities like the City of Chelsea cannot possibly encompass the high cost retrofitting their intersections, while also reconciling with impacts of outdated intersections and infrastructure along congested major roadways such as Route 16 and Route 1.

## Page ES-7:

According to Figure ES-7, the Boston MPO appears to be significantly below its Long Range Transportation Goals for Modernization. This clearly signals to the region and public transit patrons that modernization has taken a back seat in consideration of all other Long Range Transportation Goals, such as Complete Streets, Major Infrastructure and Intersection Improvements which primarily benefit car and roadway traffic. Modernization policies and

goals may be impacted by economic factors; however, an argument can be made that given the right amount of immediate financial contribution and staff attention, modernization may allay many issues associated with economic recovery initiatives and overall financial outlook for regional transit.

## Page 3-28

The dedicated funding for Silver Line's Dual Mode Articulated (DMA) Bus Replacement system in Table 3-8: FFY 2022-26 TIP Transit Table should be scrutinized further for the prospective transition to fully electric vehicle fleets. The City of Chelsea supports a fully electric Silver Line System, and proposes further that for busses along major bus routes traversing highly dense urban areas, electric vehicle retrofits and replacement should be a top priority of the Boston MPO. The Boston MPO, the MBTA, and other state level planning groups and firms should organize a national procurement of fully electric vehicle fleet technologies for vetting and adaptation by an assembly of practitioners to the Greater Boston Region. The public health and environmental benefits of such a motion would be hugely beneficial for the State of Massachusetts's most vulnerable Environmental Justice Communities.

Dear Mr. Genova and Boston MPO Board,

Thank you for inviting public comment on this draft of the Federal Fiscal Year (FFY) 2022- 2026 Transportation Improvement Program (TIP). For over 15 years, LivableStreets Alliance has advocated for streets that connect people to the places where they live, work, and play.

Our current programs include:

- **Emerald Network:** our vision for a 200-mile system of connected greenways throughout the Greater Boston area.
- **Vision Zero:** the effort to systematically improve traffic safety in cities and towns.
- **Better Buses:** systemwide improvements to optimize and prioritize bus transit.
- **Great Neighborhoods**: a statewide network of regional advocates focused on housing, transportation, and climate change.

We have reviewed the draft FFY 2022-2026 TIP and would like to provide the following comments:

#### **Cost Containment**

We recommend formalizing the project funding process. Currently there is an unwritten policy that the Boston Region MPO will cover all project cost changes once they have been programmed into the TIP. This leads to limited accountability to contain project costs and limits the MPO's ability to fund future projects; we have seen, over many years, that many programmed projects have cost increases. As reported at the February 4, 2021 MPO meeting, 27 projects were vying for funding this year with a total request of over \$300 million. However, due to currently programmed projects' cost increases, only \$3.3 million is available for new projects in FY 2026. Last year 31 projects saw cost increases, with 19 of these projects each showing increases of over \$1 million.

We are concerned that due to project cost increases, no new projects that have been scored with the updated TIP scoring criteria are receiving funding this year. We believe that the new TIP scoring

criteria will better demonstrate the value of those projects that will lead to a more equitable, sustainable, and resilient region.

As Beth Osborne of Transportation for America said during the January 2020 MPO meeting, "the best performance management processes are constantly updated based on lessons learned."<sup>1</sup> We agree and believe it is time to revamp the TIP funding process to increase accountability, which will remain limited as long as the responsibility for cost estimates is dispersed across MassDOT, municipalities, and consultants. We are further concerned that the MassDOT formula to determine cost estimates is inadequate, given the significant number of projects that increase in scope and cost. The MPO can better limit the impact of this consistent problem by following the process currently used by the Virginia Department of Transportation. We think there is benefit in CTPS staff reviewing project scope changes by doing a qualitative assessment and then requiring board approval for any potential budget increase, with the opportunity to revoke funding. This process will lead to more accurate cost estimates. We also hypothesize that this will allow for better bargaining as contractors will need to contain unnecessary scope creep.

We are happy to see that the MPO board is creating a policy change subcommittee to address this long standing funding problem. In order to achieve the most equitable outcome, it is critical to offer significant opportunities for public involvement in the subcommittee meetings. We recommend that advocates and other community stakeholders have a formal seat on the subcommittee and that the MPO allow for public questions and comments throughout the process. The recommendations made to the MPO board by this subcommittee will determine the long-term sustainability of MPO funding, which is critical for a more equitable, resilient, and sustainable region.

## Materials

The TIP project database is a great resource that makes it easier for community members to find the projects that are more interesting and relevant to them and their community. We applaud the CTPS staff for creating this helpful and visually appealing tool last year. We understand that there was limited staff capacity to update the database this year and encourage resources to be allocated to ensure this can be regularly updated and included in future TIP cycles.

#### **TIP Program Table**

Lastly, we recommend an additional column be added to the TIP program table to highlight changes as compared to the previous year's TIP as a method to increase transparency. Members of the public should be able to see, without needing to attend MPO meetings, if new projects have been added or removed each year; if project costs have shifted, especially if the change surpasses the \$20M major infrastructure project threshold; and the reason(s) why projects' costs have increased.

I have read the proposed 2022-26 TIP and am pleased to see so many excellent projects under consideration. As a member of the public and as a bike commuter, I have reduced the car mileage driving to work and on local trips by hundreds of miles per year. Therefore, I have great interest in seeing improvements to bike lanes and bike parking.

I want to go on record as strongly supporting the following initiatives:

#608164 Sudbury and Concord: Bruce Freeman Rail Trail, Phase 2D

- This is an important north-south route for both pedestrians and bikes. The full project should completed and opened as quickly as possible.

#607777 Watertown: Rehabilitation of Mount Auburn Street (Route 16)

- This project, on my bike commute from house to work, is currently a heavily-used nightmare for bikers. I liken it as trying to ride on a four-lane highway. These improvements (as well as just getting rid of potholes) will make a HUGE difference.

#609066 Weston and Newton: Multi-Use Trail Connection, from Recreation Road to Upper Charles River Greenway including Reconstruction of Pedestrian Bridge N-12-078=W-29-062

- Re-opening the pedestrian bridge over the Charles River will make the park areas much more accessible

Unfortunately, with so many worthy proposals recommended for funding, there are other areas that I would like to see supported that are NOT in the current plan:

- Transit improvements and handicap accessibility to commuter rail stations in Newtonville, West Newton, and Auburndale. Proposed and recently-completed high density "smart" housing along the Framingham-Worcester commuter line is increasing demand on these stations.
- Extension and full funding for the Mass Central Rail Trail. The 104 mile multiuse-trail to Northhampton is a dream, that I, as a bicyclist, I have had my entire adult life. Question is, will I live to see it completed?
