Scenario Description

Scenario 1B staggers delays, beginning with delaying Norwood Route 1 two years to FFY 2028. Funding for Brookline Washington Street is redistributed (not delayed), and Lynn Western Ave is delayed by one year into FFY 2029. To address the deficits created in 2029 by this distribution, Malden Spot Pond and Swampscott Rail Trail are delayed into 2030.

Scenario Benefits

Remaining balances in 2026-28 are modestly higher, and this scenario delays projects that have not had recent design/cost updates or have not progressed to 25% design. There is less cost delayed to future TIP cycles.

Scenario Risks

This scenario has low funding availability for new projects in 2030. It also delays some projects by two years instead of just one.

Scenario Description

Hingham Route 3A is funded entirely in 2026, Norwood Route 1 is delayed one additional year and funded across 2028-29, funding Somerville McGrath Boulevard is reduced in 2028-29 and increased in 2030, and Lynn Western Ave is delayed one year and its funding in 2028-29 is reduced.

Scenario Benefits

This scenario avoids pushing too much funding out into 2031 and future years by redestributing money within the cycle instead of delaying projects past 2030.

Scenario Risks

Funding Hingham Route 3A entirely in 2026 may be risky due to readiness concerns. Low allocation for funding in FFY 2026 and 2030 will limit new projects. Giving McGrath and Western Ave large "tails" means that delays would have severe impacts.
